By-Law no. _____

Being a By-law to Amend the Assessment Schedule and to Levy the Actual Costs Incurred for the Maintenance of Drainage Works Known as the Fred and John Pietz Municipal Drain

Whereas By-law No. 6495/62/17 and 435/18/75, Being By-law's to Provide for Drainage Works in the City of Port Colborne in the Regional Municipality of Niagara Fred and John Pietz Municipal Drains, consecutively were enacted on the 10th day of July 2017 and 22nd day of September 1975, and provide for the update of assessment schedules, as submitted consecutively by K. Smart Associates Limited and W J Smith, P. Eng; and

Whereas Section 74, Chapter D.17 of the *Drainage Act, R.S.O. 1990* (the Act) compels each municipality to maintain that portion of a drainage works within its limits; and

Whereas Section 61(1) of the Act authorizes a municipality, upon the completion of the maintenance of the drainage works, to levy the final cost thereof to the lands and roads liable, as stated in the Engineer's Report, so as to recover the cost of said maintenance; and

Whereas in compliance with such duty, the municipality has carried out maintenance of said drainage works as per the design of the Engineer's Report, and the total actual cost incurred was \$90,534.37;

Now therefore the Council of The Corporation of the City of Port Colborne enacts as follows:

1. That the cost of the Fred and John Pietz Municipal Drain as provided for in By-law No's. 6495/62/17 and 435/18/75, be levied against the lands and roads as set out in the assessment schedule in the Engineer's Report dated July 31, 2014, as amended, pro rata and as listed in the actual assessment column, more particularly shown on Schedules 'a', 'b' and 'c' attached hereto, to be levied and collected in the same manner as taxes.
2. The invoiced amount will be automatically added to the billable tax accounts.
3. The properties within the watershed will receive notice of the billable amount.
4. That the payments that have not been received within 90 days of the date of the notice, will accrue interest of 1.25% monthly.
5. That By-law No's. 6495/62/17 and 435/18/75 are hereby amended by replacing the assessment schedule with Schedule 'a', 'b' and 'c' appended hereto.
6. That this by-law shall come into force and take effect on the day of its final passing.
