MAN WHO ATTEMPTED TO BRING HANDGUN INTO CANADA ARRESTED

An American motorist who attempted to bring a handgun into Canada at the Peace Bridge has been arrested.

The 61-year-old man crossed the Fort Erie bridge March 16 and declared to Canada Border Services Agency officers he was carrying a Browning 9-millimetre handgun.

He was refused entry to Canada and sent back to U.S. Customs and Border Protection.

An investigation determined the man did own the gun, but he did not have a valid pistol permit.

“Our officers remain devoted to keeping our communities safe, and in this case, removing a firearm that was unlawfully possessed,” said CBP acting port director John Madsen in a release.

The motorist was arrested then turned over to Buffalo Police and charged with second-degree criminal possession of a weapon.
